Smoking Cessation

*Tobacco 21 state law

*KCHD-BOH passed a resolution to have locals munc adopt stronger rules to strengthen state law. If you don't see signs in stores, let Mike know. Education of BOH resolution. T21 is about prevention by raising the age persons begin use. Help for schools- My Life, My Quit; suspension alternative.

*New Grant- TUPC Tobacco Use Prevention & Cessation. Prgm-develop mentoring program for cessation clients. Need volunteers to mentor. Only requirement-former smoker. Helps to ensure support system to quit. Brief mentor training and then assigned to clients (matched on where they are in the process)

*Adult cessation program- 98 people enrolled for the year; program going well.

*Former Baby & Me program/ Mommy Me Tobacco Free (Mike passed out a new flyer). CVS Pharmacy Diaper vouchers- diapers, wipes, diaper cream, etc.4 prenatal, 6 post-birth voucher potential. If a partner smokes, we can connect to a regular cessation program. Mike will present to the KCH Birthing Center.

	<p>*ODH Webinar- Educate about Tobacco Quit Line. Mike will provide a link to Carmen to send out. Quitline can send up to 8 weeks of patches. MH and anxiety is factored into quitline support. Kelly will add to Women United News Letter</p> <p>* Commissioner Pursel- Employer program to raise premium is now illegal; Dept of Labor. Have tobacco prevention specialists found an alternative or work around? Mike can do a cessation program for employers. Jeff (KCH)- Not aware this program is illegal. Explained KCH process. Julie- Give points instead of increasing premium.</p> <p>*MW- Make sure employees are quitting instead of attending a class.</p>
