

# Soil Scientist List / Soil Evaluators



The following is a list of Soil Scientists who are qualified and known to work in Knox County. A soil report must be completed by a Soil Scientist before a site review by Knox Public Health (KPH) can be done. It is the property owner's responsibility to contact a soil scientist to schedule a soil evaluation of their property. The property owner also needs to have the site cleared of brush and debris, house / building staked, and water well location marked. This is to ensure the most accurate review of the site by the soil scientist and KPH. **It is the responsibility of the owner to see to it that the general contractor, well driller, and all other parties stay off the proposed area of the septic system. Soil disturbance in the area could result in a re-evaluation of the site.**

Discuss with your soil scientist the options for submitting a soil report to KPH. The original soil report is preferred by KPH, however, a colored copy of the soil report is acceptable.
